## LIABILITY TERMS AND POLICIES

I, [REDACTED], the parent or legal guardian of the student I am enrolling (self if over 18) understand that dance and dance-related activities present a risk of injury. I understand that said risk cannot be eliminated regardless of the care taken to avoid injury, and I agree to assume that risk in order for my student to participate in these activities.

I understand that it is my responsibility to consult with a physician regarding my student prior to enrollment in classes, performances, or other dance activities, and I hereby acknowledge that the student is in good health and does not have a medical or physical condition or history of a condition that would place the student at risk while participating in activities at Fidalgo DanceWorks.

I agree to assume full responsibility for any risks, injuries or damages that may occur as a result of my student's participation at Fidalgo DanceWorks, and I do hereby release and forever discharge Fidalgo DanceWorks, its board of directors, employees, contractors or volunteers from all claims, expenses, attorney fees and causes of action or suits of any kind or nature associated with my student's involvement with Fidalgo DanceWorks, including but not limited to injuries sustained, illnesses contracted, or personal property lost.

## TUITION & FEES/TERMS & POLICIES

Tuition is due on the first of the month for that month. For example, September tuition is due on September 1. With notification to the office, changes to enrollment may be made at any time before the first of any month. Tuition will continue to accrue until official notification of withdrawal has been received.

**We do not prorate due to holidays, weather or school closure.**

**Make-up Classes:** There is no refund for missed classes. However, students are always welcomed and encouraged to make-up classes missed. Check with the office for an appropriate make-up class for your dancer.

**Dance Dress Code:** Required dance wear and dance shoes must be worn to all classes. Failure to wear required dance wear to class could result in students being asked to sit out the class. Students are not permitted to wear jeans, graphic tees or shoes worn on the street or outdoors to any dance class. For safety reasons dancers are not permitted to wear jewelry. Hair must be worn in a ballet bun for all ballet classes or pulled back in a ponytail for all other dance forms.

SUMMER TUITION IS CHARGED AS ADVERTISED ON THE SUMMER SCHEDULES.

For students who participate in performances, additional costume and/or participation fees may be assessed. These fees are non-refundable and must be paid in full by the published due date. Students in performances are liable for associated costs regardless of changes in enrollment plans.
